RESEARCH AND POLICY INTEREST

I am generally interested in the political economy of development; government outsourcing or public procurement reform and social justice; non-state actors; comparative institutional & historical analysis; contentious politics; gender, sexuality and politics; law and culture.

- ✓ **Identity economics and politics:** I am interested in the ways in which our personal and collective sense of “who we are” impacts economic and institutional relations.
- ✓ **Government outsourcing and human rights:** is public procurement and public-private partnerships displacing or reinforcing human rights and especially the wellbeing of vulnerable groups in society? How do we create a more accountable partnership between the public and the private sector while promoting socio-economic wellbeing? How can public procurement improve governance in the world?
- ✓ **Gender, sexuality and politics:** how is gender and sexual identity negotiated in contexts where human rights are contested? What are other mechanisms besides state-centered approaches that could foster inclusive and sustainable communities? How is the idea of individual freedom manifested in different socio-cultural and political contexts? How is gender and sexual identity subverted in otherwise well functioning institutions? What role does religion play in sexual identity negotiation?
- ✓ **Strategic interactions:** How do people and communities establish lasting relationships in a context of asymmetric power and inequalities? Under which circumstances contracting transforms economic and political inequalities for worse or better? Applying a game theoretic framework to identity negotiation analysis.
- ✓ **Ethics and social transformation.** What are the frontiers of Western liberalism and what is the role of spiritual imagination in socio-cultural and political transformation? What values can one derive from indigenous ethical frameworks to imagine more equal and inclusive societies today?

- ✓ *Introduction to African Politics*. This course is designed to look at contemporary African politics from the perspective of State and non-state actors to discuss ideas and practices of citizenship. Spring, 2016.
- ✓ *Introduction to Methods (Game Theory)*. This course introduces the core concepts of game theory and how it helps understand political and social phenomena. It emphasizes decision making, model building skills and problem solving. Spring, 2016.
