### **Tertiary Education:**

2008 - 2012 Completed PhD studies at Rhodes University, Grahamstown. Title of Thesis: *Transgressive Christian Iconography in Post-apartheid South African Art*. This study proposes that transgressive interpretations of Christian iconography provide a valuable strategy for contemporary artists to engage with perceived social inequalities in post-apartheid South Africa. Working in the light of Michel Foucault's idea of an 'ontology of the present', I investigate the ways in which religious iconography has been implicated in the regulation of society. Parodic reworking of Christian imagery in the selected examples is investigated as a strategy to expose these controls and offer a critique of mechanisms which produce normative 'truths'. I also consider how such imagery has been received and the factors accounting for that reception.

1998 – 2000 Completed, with distinction, a Master of Arts Degree in History of Art at the University of the Witwatersrand.

As partial requirement for this degree a dissertation was submitted entitled: *Female Bodies – Male Control: Works from Leora Farber's* <u>Skinless</u> and <u>Instrumental</u> *Exhibitions.* 

This study demonstrates how selected examples of Farber's works comment on the construction of gender roles and convey insights about the ways in which patriarchal stereotyping operates as a form of control. It is suggested that Farber conveys reference to various artistic protocols that have been used in such a way that they manage and contain the female body, and that concomitantly her works divest those protocols of their efficacy.

The dissertation discusses the influences on Schwitters' life in his move towards a Total Work of Art, as well as identifying the parameters that define the idea of the Gesamtkunstwerk. It also deals with the content and development of Schwitters' Hanover Merzbau in depth, to ascertain the extent to which his Merzbau could be classified as a Gesamtkunstwerk.
